

# 50th anniversary meeting! BURLINGTON GELEBRATE THE PAST 2000 GELEBRATE THE FUTURE





## PHILLIPS EXETER ACADEMY'S PROACTIVE ROLE WITH NATURAL RESOURCE MANAGEMENT PLAN

ew Hampshire is facing a continued decline of grassland habitat due to land conversion for development, loss of farms, and other factors. Grasslands presently occupy less than 10% of New Hampshire's landscape. This has resulted in a decline of the bird species that utilize this valuable habitat. Phillips Exeter Academy has undertaken a pro-active role in developing a natural resources management plan addressing the natural resources of its forests and fields. This plan includes selective forest thinning, cutting of clear patches to enhance wildlife development, and the improvement of running and hiking trails. Additional initiatives are now underway.

A new area of approximately 10 acres in size, north of the Old Benedetto farm, has been cleared of overtaking shrubs and young trees. This area will be maintained in tall grass, which will provide habitat for certain bird species. While we are mainly hoping to attract the Bobolink, other species that may use the area include: Eastern Meadowlark, Vesper Sparrow, Savannah Sparrow, Grasshopper Sparrow, and Henslow's Sparrow (listed as an endangered species in New Hampshire). Ring-necked Pheasant, and American Woodcock should also benefit. This area will be mowed only late in the season after nesting species have matured and moved on. The progression of this area should be interesting.

We are planning the establishment of wildlife patch cuts in combination with a limited forest thinning west of the Colby Farm Field toward Great Meadows. This project should be completed by the end of the summer. We will be watching for increased wildlife activity in these areas.

Thinning of the pine stand south of the stadium will be completed this summer. The work will be accomplished with a small track driven machine. This should provide a good comparison with the adjacent area completed last year with horses.

Efforts are ongoing to permanently protect certain parcels of academy land through conservation leasements. This has been a challenging and informative process.

## Burlington 2000 Field of Dreams Strategy Targets K-12 Professional Membership

recently had the pleasure of attending the annual APPA meeting in Fort Worth, Texas, as in 106 degrees in the afternoon and a cool 80 degrees at night. Yes, in spite of the heat, it was fun and satisfying. While there, I was able to participate in updating people about our Burlington 2000 meeting and be part of the Membership Committee discussions. Also, Ed Smith and I provided a presentation to the membership on the status of the K-12 Task Force. There were overlapping elements of each session that just came together.

Ed is the Director of Facilities at the University of Rhode Island and is also the chairperson of the K-12 Task Force. We brought everyone up-to-date as to progress regarding the three objectives (Education, Networking and Information Sharing) and reviewed the following goals;

- F Develop an education program that is targeted to meet the needs of the K-12 community.
- F Establish a K-12 web-site presence on APPA's web-site that will include; resource contacts, tools, performance indicators, and best practices information.
- F Develop membership marketing information geared toward the K-12 committee with a presence at the APPA international, regional, chapter and/or state levels.

The membership discussions tied in nicely with positive support for developing K-12 membership through the APPA regions. Good recognition was given to the need to implement the K-12 Task Force "Field of Dreams" strategy. In short, APPA has the resources and education opportunities that appeal to all facilities professionals within higher education and K-12. Once people are aware of those resources, they are more likely to become members. In other words, make people aware of the APPA opportunities and resources and they will join. APPA has take positive actions to make membership more appealing to all facilities professionals. That is good progress.

How does the above connect to the upcoming Burlington 2000 meeting? Well, in several ways. The education program contains many opportunities that will appeal to a wide range of facilities managers, including K-12 potential members. Ed Smith will also provide a leadership and organization challenges presentation with a focus toward K-12 and small college facilities managers.

## APPA SCHOLARSHIP PROGRAM POLICIES & GUIDELINES

- 1. The APPA Scholarship Program was established "in order to stimulate further development in the field of facilities management and to advance the purposes of the Association." according to APPA Bylaws.
- Only persons presently employed full-time in the field of facilities management at an APPA member institution are eligible.
- 3. Scholarship recipients will be selected by the **regional organizations** and will be awarded by the Educational Programs Committee on an individual basis. (Most regions also offer their own Institute scholarships. *See regional criteria for additional scholarship requirements.*)
- 4. The **amount** of a scholarship grant will be at the discretion of the **Educational Programs Committee**. Normally, scholarships will be granted to cover registration fees at APPA's Institute for Facilities Management.
- One registration scholarship per region for each APPA Institute has been authorized by the APPA Board of Directors.
- Preference will be given to persons who plan to pursue or continue a career in facilities management and who display high motivation and leadership ability.
- Scholarships will normally be granted to an individual only once.


#### **NNECERAPPA at Burlington 2000**
